She is wanting to obtain her cosmetologist's license, but in the meantime would lease out studios to licensed cosmetologists and open a boutique as well. One portion of the property will be a salon and the other a boutique. She is currently leasing the property. She would not be performing any cosmetology services until license is obtained, but will be at the business regularly for cleaning and maintenance.
