Chairman Grotegeers brought forward Case 24-02: Front Yard Storage Variance—A request from Trinity Partners for a Variance from Section 400.160.C.4 of the Zoning Code to store electrical equipment in a front yard at 8801 Seeger Industrial Drive, Berkeley, MO 63134.

Bruce Harper was present as representative of the case along with Dan Lesinksi and Billy Spence.

Mr. Harper stated that there was a need for outdoor storage at the property at 8801 Seeger Industrial Drive. They will be leasing the far-right suite space at the end of the 40,000 square foot space and will need an extra 1,000 square footage of space to store material. They are desiring to allocate space to store this material to accommodate their expansion needs. Chairman Grotegreers asked if the area will be fenced off. Mr. Harper stated that standard chain link fencing would be installed. However, he is comfortable with the neighborhood and does not see the need for surveillance.

Member Holmes made the **MOTION** to approve the variance. Member West **SECONDED** the motion. The motion passed by a voice vote 3:0. Grotegeers, Holmes, West.
